Mayor Pro Tem Strnad opened the public hearing regarding an amendment to the Marion Comprehensive Plan establishing Airport and Airport Overlay designations. (City of Marion). Community Development Director Tom Treharne provided staff report.

The following spoke in favor of the measure:

Phil Legate (2695 Pebble Creek, Marion) spoke in regards to airport noise levels and noise mitigation options. Mike Much (4375 Pioneer Trail SE, Cedar Rapids) spoke in regards to condition of existing runway, need for a crosswind runway, and flight club at the airport. Mayor Pro Tem Strnad asked how many members are in flight club. Mike stated eight paid members and 30 on the wait list. Justin Redig (1375 Parkview Drive, Marion) spoke in regards to the flight school and future growth and expansion. Kurtis Grimm (3106 Carlisle Circle, Marion) spoke in regards to how aviation is growing and future growth. Cole Norton (P&N Flight School, 1710 Marion Airport Road, Marion) presented information about the need for improvements and current activities at the airport. Jan Walton (1660 Marion Airport Road, Marion) was the previous owner of the airport and spoke about the progress through the years. Kyle Setrum (1742 Para Drive, Marion) spoke in regards to smaller airports. Wendy Kunkle (1840 Geode Street, Marion) spoke in favor and stated her son attended P&N Flight School. Tim Schaffer (1775 Maplecrest Drive, Marion) spoke as chair of Marion Municipal Airport Committee and stated they support the ALP as approved. Nick Glew (MEDCO, 1225 6th Avenue Suite 100, Marion) spoke in regards to commercial development surrounding the airport.

The following spoke in opposition of the measure:

Bill McCartan (Bradley & Riley, 2007 1st Avenue) spoke for his client Atlas LP Company which owns land surrounding the airport. Stated that money should be spent on other community assets which benefit majority of City. Amber Jordan (1493 Martin Creek Road, Marion) owns farm near airport. She stated she is okay with current airport but can't get answers of how their farm will be impacted. Laurie Copper (2145 Mark Lane, Marion) spoke in regards to the bog near the airport and mitigation. Stephen Coffin (1210 Marion Airport Road, Marion) has family which owns land. He stated by expanding the class of the airport will change and allow bigger planes to land. Jeff Coberly (1586 Secrist Road, Marion) owns wetland near the airport and needs a lot of questions answered before this project moves forward. Lisa Coffin (1210 Marion Airport Road, Marion) has family that owns 132 acres near the airport and is against this project

for reasons already stated. Cindy Kettelkamp (1310 Secrist Road, Marion) owns land next to the airport and stated a lot of small business already occur next to the airport and a lot of investment has already taken place in other projects in the area. Greg Churchill (1700 Cottage Grove Parkway, Marion) owns 1100 acres near the airport and stated if you look at other comparable airport like Monticello, there is no development near them. Brad Bennett (2280 Timber Creek Drive, Marion) spoke against the airport.

No other comments, written or verbal, were received. Mayor Pro Tem Strnad declared public hearing closed.

Moved by Brandt, seconded by Jensen to approve Resolution No 27752 approving an amendment to the Marion Comprehensive Plan establishing Airport and Airport Overlay designations. Council Member Jensen stated he is strong believer in long term planning but the current plan comes with a number of restrictions for the land surrounding. Council Member Gadelha thanked all those who came to speak. She stated she is in favor of updated existing runway but not in favor of additional runway. Council Member Draper has a conflict with the East/West runway. Council Member Atkins thanked all those who spoke tonight or emailed. Council Member Brandt stated he was on Council when ALP was approved. He stated he doesn't think anyone currently on Council would be in favor of spending money on East/West runway in the next several years but this plan still needs to be in place to protect the land in case we need the East/West runway in the future. Mayor Pro Tem Strnad stated he was on the Council when ALP was being developed. He asked if vote tonight is for expanding the Comprehensive Plan to incorporate airport. Community Development Director Tom Treharne confirmed. Mayor Pro Tem Strnad stated he'd like to see the ALP amended and show phases. Tom stated we could incorporate just the North/South runway in the Comprehensive Plan Amendment. City Manager Lon Pluckhahn stated if Council wants to amend the Comprehensive Plan to just include North/South runway, he recommends this item be tabled so staff have some time to prepare as it could be a substantial change. City Attorney Kara Bullerman agrees with Lon's statement. Moved by Jensen, seconded by Atkins to table Res. No. 27752. Vote: Yeas: Atkins, Jensen, Strnad, Brandt, Gadelha. Nays: None. Abstention: Draper. Motion to table carried.

Moved by Gadelha, seconded by Jensen to table motion directing staff to proceed with zoning the Marion Municipal Airport consistent with the 2017 Airport Layout Plan. All in favor of motion to table, motion carried.

Moved by Atkins, seconded by Gadelha to direct staff to proceed with a city-wide rezoning based on the September 2018 adopted zoning districts. All in favor, motion carried.

OTHER DEPARTMENT DISCUSSION – No discussions took place.

PUBLIC FORUM

Kim McDaniel (TNR Community Cats, 3098 3rd Street) spoke regarding a trap-neuterreturn (TNR) program that would resolve some cat overpopulation issues near trailer parks or apartment buildings.

Charisma Tandy (Community Cat League, 215 D Street, Walford) spoke in regards to cat overpopulation and advocates for the TNR program.

Robert Buckley (2730 Heather View, Marion) spoke in opposition of the Pride Event at the Library.

Jennifer Tibbetts (1033 7th Street, Marion) spoke on behalf of the Civil Rights Commission and spoke in favor of the Pride Event at the Library.

John Braumann (257 13th Street NW, Cedar Rapids) spoke in regards to cat overpopulation and advocates for the TNR program.

COUNCIL DISCUSSION

Council Member Jensen presented an award the City received for its work with Encore Café. Also stated he ate at Urban Pie and on Monday nights they currently have specials if you are a Marion resident.

Council Member Draper provided some historical information from 1957 and also stated he'll be celebrating his 62nd wedding anniversary this weekend.

Council Member Gadelha provided some information regarding the Citizen's Fire Academy. Encouraged citizens to attend as she learned a lot of information when she participated.

Council Member Brandt congratulated Council Member Draper and his wife on their anniversary. He gave a reminder regarding the Patriotic Picnic in the park this weekend as well as stated he'll be in the Library for Council hours Saturday morning.

Mayor Pro Tem Strnad thanked everyone for their patience tonight. Stated the Prince tribute band is this weekend out at Lowe Park as well as the Marion Airport Fly-In breakfast. The Fire Department will be out at the breakfast doing a fireworks safety presentation. He also thanked all those who spoke tonight.

Mayor Pro Tem Strnad adjourned the meeting at 8:52 p.m.
