All meetings are held in the Marion City Council Chambers at City Hall, 1225 6th Avenue, unless otherwise noted:

- Deadline for Planning and Zoning Commission agenda is the day before the previous month's meeting (on a Monday).
- Deadline for the Zoning Board of Adjustment is the last working calendar day of the preceding month.
- The Subdivision Review meeting is held on the Thursday after Zoning Board of Adjustment in the 2nd Floor City Hall Conference Room.
- The Planning and Zoning Commission meets at 6:00 p.m. the second Tuesday of every month.
- The Zoning Board of Adjustment meets at 7:00 p.m. the third Tuesday of every month.
- Historic Preservation meets at 7:30 a.m. the second Tuesday of every month.
- The Marion City Council meets the first Thursday of the first full week of the month and the third Thursday, with a Work Session on the preceding Tuesdays. Regular City Council meetings are held at 5:30 p.m.
