- Discussion regarding Marion Civil Service Rules. (Attorney Patrick O'Connell with Lynch Dallas)

Patrick O'Connell provided an overview of proposed changes to the Marion Civil Service Rules. Rehn asked if disciplinary hearings are closed session. O'Connell said appeal hearings would be an open meeting but disciplinary hearings would be closed as long as employee requested it to be a closed session. Krebill asked about the Civil Service

Commission interviewing firefighter applicants. O'Connell said those can be in closed session if requested by the applicant. Bolender asked about applicant testing since there are 2 or more commissioners present. O'Connell stated since there is no action or deliberation taking place an agenda would not need to be posted. Kitsmiller asked for clarification on interviews if only one commissioner is present. O'Connell stated it would only be an open session only if there is a quorum present and would add such language to the rules. O'Connell continued explaining the Marion Civil Service Rules.
