# Presentation and discussion regarding the Solid Waste Utility and Fiscal Year 2023 Rates

Michael Maloney with D.A. Davidson provided information regarding Marion's Solid Waste fund and then discussed rate increase considerations. An ordinance with proposed rate changes will come forward at the August 4 meeting.

## Presentation regarding the Indian Creek Master Plan for Creekside Pride (ISG)

Staci Williams with ISG spoke regarding the Indian Creek Master Plan and presented nine site locations and outlined the features of each. Councilmember Mentzer asked if anyone living next to the proposed sites has been opposed. Williams stated they have not heard any comments in opposition. Councilmember Jensen asked how many miles are between site one to site nine. Williams stated it is approximately nine miles. Mayor AbouAssaly thanked everyone who was involved in this plan.
