Staff would like to have two test dates this next round to increase applicant participation. Tests are scheduled for Saturday, February 25 and Wednesday, March 1. The test dates will have identical examinations and the applicants may choose either date. Clerk Rachel Bolender stated scoring and the announcement of successful applicants will occur simultaneously. Kadlec and Rehn stated they will both be present at the tests.

Fire Chief Tom Fagan discussed that two members of the department will be leaving in the next year and so there needs to be a plan for those replacements. Over the next six months staff will be working to fill those positions. The department is looking at other opportunities to attract firefighters to Marion including lateral transfers.
