PLANNING & DEVELOPMENT ACTIVITY

Zoning Ordinance – Amendments in process:

- Completion of Zoning Ordinance as part of codification is going through final review to be forwarded to the February Planning and Zoning Commission.
- Work has begun to implement a street tree ordinance for all new developments. A draft has been prepared and reviewed with Parks Department staff. Review of those comments is ongoing.

COMMERCIAL BUILDING ACTIVITY

The Building Department has 44 active commercial permits. 5 new commercial permits were issued while 4 were completed. There are a lot of inquiries on potential new projects, but most are concerned over the shortage of building materials, labor cost or both, along with the higher interest rates. With this said and the announcement of the Mercy and St. Luke's ER's it is encouraging that we could have another very busy year.

The 5 new permits issued are all remodel projects. Framing for Green Park Apartments and Marion Boulevard Apartments continues with both getting the rough-ins started and getting the buildings ready for insulation. Tulip Tree apartment contractor has indicated that their project will start coming out of the ground in spring as the installation of the aggregate pier footings has been completed.

CODE COMPLIANCE ACTIVITIES

Code Compliance continues to work 62 active cases and to respond to nuisance properties as they are identified. There are currently 17 order to abate nuisances waiting for compliance along with the continued influx of daily complaints. The current case count involving legal action is at 7. As a result of enforcement on a prominent uptown property, staff has identified several properties needing repairs and maintenance. Notices detailing the demands with aggressive timeframes have been sent out and time has lapsed on some. Staff is working with Lynch Dallas to proceed with municipal infraction when necessary.
