

Monthly Report February 2023

PLANNING & DEVELOPMENT ACTIVITY

Zoning Ordinance – Amendments in process:

- The Zoning Ordinance as part of the recodification process was recommended for approval by the Planning and Zoning Commission on February 14th and proceeded to City Council for the public hearing and initial consideration as part of the broader codification process.
- Work has begun to implement a street tree ordinance for all new developments. A draft has been prepared and reviewed with Parks Department staff. Review of those comments is ongoing.

Long-Range Planning Documents:

- A draft RFP for the Parking Study began. The RFP is anticipated to be pushed out for proposals by the end of March.
- Staff continued to review award winning Comprehensive Plans to gain insight of elements that would be good to include in Marion's update as we prepare to write the RFP.

COMMERCIAL BUILDING ACTIVITY

The Building Department has 36 active commercial permits. No new commercial permits were issued while 8 were completed. There are a lot of inquiries about potential new projects, but most are concerned over the shortage of some materials, and the higher interest rates. With this said and the announcement of the Mercy and St. Luke's ER's it is encouraging that we will have another very busy year.

Framing for Green Park Apartments and Marion Boulevard Apartments continues with both getting the rough-ins completed on the upper floors and getting the drywalling moving forward. The Tulip Tree apartment contractor has indicated that their project will start coming out of the ground in spring and the installation of the aggregate pier footings has been completed.

CODE COMPLIANCE ACTIVITIES

Code Compliance continues to work 51 active cases and to respond to nuisance properties as they are identified. There are currently 19 order to abate nuisances waiting for compliance along with the continued influx of daily complaints. The current case count involving legal action is at 9. As a result of enforcement on a prominent uptown property, staff has identified several properties needing repairs and maintenance. Enforcement on the Carriage Corner development has also led to several other properties to be identified as in need of moderate derecho damage repairs. Orders to Abate have been sent out on these properties and staff is currently waiting for compliance of deadlines before proceeding to the next step.

TRAIL PROJECTS

In February, the Linn County Trail Association donated \$100,000 to the City of Marion to support the advance design of the Lucore Road sidepath and pedestrian bridge project.
