### PLANNING & DEVELOPMENT ACTIVITY

### **Long-Range Planning Documents:**

- Reviewed RFP proposals regarding uptown parking study and recommended HKGi as the consultant. Contract to City Council in August 2023. Project completion in March 2024
- Received four RFP proposals for Marion Comprehensive Plan Update. Review RFPs and make selection in early August for September 2023 contract to City Council for approval. Project Completion March 2025

### **COMMERCIAL BUILDING ACTIVITY**

The Building Department has 42 active commercial permits. One new commercial remodel permit was issued in the month of July, one project was completed. There are 2 more projects that will be submitting soon, it is shaping up to be a very busy fall.

Green Park Apartments contactor is starting to get occupancy inspections and Marion Boulevard Apartments should not be far behind. Tulip Tree Apartments contractor is working on the framing and moving along very well with the roof going on soon. Marion Independent Schools has started the Parkview Elementary, it is coming out of the ground nicely and work is beginning for the new Auditorium addition and Linn Mar's Administration building.

### **CODE COMPLIANCE ACTIVITIES**

Code Compliance has 62 active cases and continues to respond to nuisance properties as they are identified. There are currently 15 orders to abate nuisances waiting for compliance along with the continued influx of daily complaints. The current case count involving legal action is at 12.

The final chapter to a case at 1081 27<sup>th</sup> Street, which has lasted 3+ years has started to unfold. Staff and Lynch Dallas has worked with the original property owner and their attorney while they move forward with a forfeiture of real estate contracts. Once this process is completed, it should bring some resolution to the constant property maintenance issues this neighborhood has had to endure.

Staff has continued to take complaints on the Carriage Corner development structures. Complaints are almost always the same with tall grass and unsecured vacant structures topping the list. There has been no effort to repair any deficiencies on the 7 structures left on Seven Hills list of properties that involve enforcement.

### TRAIL PROJECTS

Closeout documentation and construction audits continue on the 10<sup>th</sup> Avenue sidepaths, Indian Creek Trail, and bridge over Marion Boulevard.

In July, staff held a kick-off meeting with Shoemaker Haaland regarding the Lucore sidepath and pedestrian bridge project.
