PLANNING & DEVELOPMENT ACTIVITY

Long-Range Planning Documents:

- The Parking Study has begun with a Staff Kick-Off Meeting with Hkgl consultants. Initial parking counts will occur throughout September 2023
- Received four RFP proposals for Marion Comprehensive Plan Update. Consultant Selection committee recommended RDG Consultants. Contract work through August for an October 5, contract approval at the City Council.

COMMERCIAL BUILDING ACTIVITY

The Building Department has 45 active commercial permits with 1 project getting completed this month. 4 new commercial remodel permits were issued in the month of August, expectations of 2 more projects being submitted soon. It has been a year of small remodels or large projects and with what is currently going it's shaping up to be a very busy fall.

The Green Park Apartments contractor should be getting final occupancy very soon with 2 of the 3 floors having occupancy. Marion Boulevard Apartments should not be far behind, while at Tulip Tree Apartments the contractor is working on the framing and moving along very well with the building being enclosed soon. The Marion Independent Schools contractor continues to work on Parkview Elementary which is coming out of the ground nicely. Work is continuing on MISD's new Auditorium addition and Linn Mar's Administration building.

CODE COMPLIANCE ACTIVITIES

Code Compliance has 53 active cases and continues to respond to nuisance properties as they are identified. There are currently 13 orders to abate nuisances waiting for compliance along with the continued influx of daily complaints. The current case count involving legal action is at 13.

1081 27th Street continues to be an eyesore. Although ownership has reverted back to the original owners, the structures have not been vacated yet. There has been a large influx of debris and garbage on the exterior as a result of the previous residents slowly working towards vacating the property. Several police calls and complaint calls have been responded to.

TRAIL PROJECTS

Closeout documentation and construction audits continue on the 10th Avenue sidepaths and Indian Creek Trail. All documentation and final reimbursement requests have been made for the bridge over Marion Blvd.

In August Shoemaker provided staff with initial cost estimates for alternate routes and discussed with staff the pros and cons of each alignment. Next step to reach out to impacted property owners to begin discussions regarding easements.
