

Pervious Paver Rebate Application Form

Marion Pervious Pavers Rebate Program Guidelines:

- 1) Identify the area where pervious pavers are desired. To qualify for the rebate, the impervious area draining to the pervious pavers must be greater than 500 square feet.
- 2) Conduct a percolation test and ribbon test to identify the type of soil in and its infiltration rate. If the drainage rate is less than 1" per hour, a subdrain may be needed for the pavers.
- 3) Complete the Pervious Pavers Rebate application. Submit application along with a site plan that shows compliance with Iowa Stormwater Management Manual standards at City Hall or mail to: City of Marion Stormwater BMP Rebate Program, 1225 6th Avenue, Suite 200, Marion, IA 52302.
- 4) The Marion Engineering Department will review the application and notify you when the application has been approved and you can proceed with the project.
- 5) Contact lowa One Call 1-800-292-8989 to have your yard flagged for utilities in the project area.
- 6) Install pervious pavers according to your site plan.
- 7) The Marion Pervious Pavers Rebate can be used towards the purchase of pavers, subdrain, and the aggregate used for storage below the pavers.
- 8) When construction of your pervious pavers is complete, contact the Marion Engineering Department at 319-432-6340 to schedule an inspection.
- 9) To get your rebate, complete the Proof of Purchase Form and submit it along with all receipts.

TERMS AND CONDITIONS

- Rebate covers 50% of the cost of pervious pavers project, up to a maximum reimbursement amount
 of \$1000. Limit of one pervious paver rebate per residential property. Items covered by the rebate
 include: pavers, subdrain, and the aggregate used for storage below the pavers.
- Applicant must be a City of Marion utilities customer.
- Applicant is solely responsible for purchase, installation, and maintenance of pervious pavers.
- Applications must be submitted and approved by the Engineering Department prior to making any purchases. Purchases made prior to approval may not qualify for rebate.
- Applications will be reviewed by City staff within 15 days.
- Project must be completed within 6 months of application approval.
- The approved application along with itemized and dated receipts must be submitted for rebate payment within 30 days of completion of the project.
- Rebate checks will be issued to the account holder unless otherwise established.
- Rebate will not be issued until project is inspected by city staff to confirm that installation complies with submitted plans.
- Rebates may be subject to income tax. Consult your tax advisor for more information.
- Rebates are subject to the availability of funds.
