#### **COMMERCIAL BUILDING ACTIVITY**

The Building Department has 43 active commercial permits with just one project getting completed this month. Eight commercial building permits were issued in the month of November, which is fairly high for this time of year, many are small remodels and one new greenhouse at Blooms.

Marion Boulevard Apartments has full occupancy and is working to get the last few items finished up. Tulip Tree Apartments should be wrapping up in early 2024. Their contractor is working on drywall, painting, and finishing work on all floors. The Marion Independent Schools contractor continues to work the Parkview Elementary and is getting that building enclosed. Work is continuing on Linn Mar's Auditorium addition and Administration building.



# **CODE COMPLIANCE ACTIVITIES**

Code Compliance has 49 active cases and continues to respond to nuisance properties as they are identified. There are currently 11 orders to abate nuisances waiting for compliance along with the continued influx of daily complaints. The current case count involving legal action is at 12.

Current assessments of the Carriage Corner Development and other properties stilled owned by Seven Hills East LLC have shown that little to no attention is being given to maintain or improve the property maintenance deficiencies noted at the onset of enforcement. Staff is hopeful that working with the owner and their attorney will bring much needed attention to these properties.

### TRAIL PROJECTS

**CeMar:** Easement documents for the Bjornsen/Atlas properties were sent to the appraiser for review and feedback. Additional easements are needed and staff is discussing with those owners.

**SRTS:** On November 27, 2023 staff submitted a Safe Routes to Schools Grant application to the lowa DOT. The project has been in the CIP for \$504,000, 20% of that will be local match. The project will infill sidewalk gaps north of Longfellow Elementary. Notice of award is expected in February 2024.
