- Mercy Emergency Department is on schedule. Most interior inspections have been completed.
- Holiday Inn Hotel rough ins have been completed, sheetrock is being installed on upper 3 floors and some pre-rock in areas on first floor.

- Eight vacant building cases are proceeding to municipal infraction hearings at the beginning of July. These cases mark the first instances of such actions and are expected to establish precedents for future similar cases.
- A cease-and-desist letter was sent to the residents of 1405 Alpine Road due to their significant use of city-owned property as their own. Despite multiple prior requests to remove their items, they did not comply with our demands. Consequently, we hired a crew to remove the items.
- Staff continues to respond to multiple requests for clean-up of neighboring property generated through the public's monitoring of their neighborhoods.
