

MINUTES City Council Work Session

The City Council of the City of Marion, Linn County, Iowa met in informal work session, Tuesday, July 16, 2024, at 4:00 PM, in the Council Chambers of City Hall, 1225 6th Avenue, with the following members present:

PROCLAMATIONS/OATHS

Police Department Promotion: Sergeant Cory Berning to Lieutenant

Police Chief Mike Kitsmiller spoke about the lieutenant position, shared Cory Berning's accomplishments and recognized his promotion.

PRESENTATIONS

Annual Presentation of the Marion Planning & Zoning Commission and the Marion Zoning Board of Adjustment

Planning Division Manager Dave Hockett and Commission Chair Landis Wiley provided an overview of the Planning & Zoning Commission and items reviewed in 2023. Councilmember Jensen asked about the review of items on the Commission and if members bring their own opinions forward when making decisions. Wiley stated a lot of the discussion is regarding the language of the code so answers are black and white but members do not hesitate to bring thoughts and ideas forward. Councilmember Mentzer asked about the decision process and if the Commission has all the tools it needs. Wiley spoke about the comprehensive planning process and issues they've seen when proposals come forward by developers. Mayor AbouAssaly requested Commission members come forward if they have recommendations or feedback for Council. Hockett also provided an overview of the Zoning Board of Adjustment and items they've reviewed in 2023.

OTHER DEPARTMENT DISCUSSION

Discussion Regarding FY 25-26 Budget: Financial Policies

Finance Director Lianne Cairy provided a timeline and an overview of the Fiscal Year 2026 budget calendar, and discussed a change to take place in the Reserves and Contingencies Policy.

Discussion Regarding the Fire Department Accreditation

Fire Chief Tom Fagan provided information regarding the accreditation process and how it aligns with Marion and department goals. A timeline of the accreditation process was shared. Fagan also introduced Management Analyst Jamie Doyle to the team who started on June 15. Doyle will play a big part in the accreditation process. Councilmember Harper asked what the re-audit frequency would be once the accreditation hearing takes place. Fagan stated one requirement is that a compliance report be submitted annually for four years following accreditation and on the fifth year the City would apply for re-accreditation. Councilmember Jensen asked about the impact on the department for the potential increase in workload. Fagan stated the team has been preparing for accreditation for a number of years but more work is needed. The entire team is excited for this next step.

UPCOMING AGENDA REVIEW

City Council review of the July 18, 2024 agenda - Council discussed the agenda items with no action taken.
